



A CALL FOR POSTER AND PLATFORM PRESENTATIONS

Have you submitted an abstract for CSM 2023? Are you interested in sharing your research with your colleagues? This is an excellent opportunity to share the findings of your studies with others and gain practice presenting a poster or performing a platform presentation.

At the 2022 APTA Indiana Fall Conference, we will have poster and platform presentations from therapists and students in research, special interest, case study, or theory reports. This opportunity is open to all PTs and PTAs with eligible presentations.

SCHEDULE FOR SATURDAY, OCTOBER 22, 2022

Platform Presentations – 9:30 – 10:30 am

Platform presentations are oral presentations of approximately 5-10 minutes. This is designed to be a short presentation on your research topic, which may include research, special interest, case study, theory report, or a clinical pearl. Time for questions will be allowed at the end of the session. Final details will be provided to those accepted, prior to the Fall Conference.

Poster Presentations – 12:00 – 1:15 pm

This is an open time for those in attendance to view the posters, meet the authors, and ask questions. The posters will be assembled the morning and should be up by 12:00 pm. The poster session will end at 1:15 pm. Final details will be provided to those accepted, prior to the Fall Conference.

The APTA Indiana Fall Conference will be held at the Courtyard by Marriott in Downtown Fort Wayne. APTA Indiana Members who are registered for the Fall Conference will have no additional cost for platform or poster presentations. For non-members, or members not registered for the Fall Conference, there will be a \$25 charge for admittance into the Exhibit Hall and will also include lunch.

An abstract of your poster or platform presentation is required by **August 26, 2022** before 11:59 pm ET and should be sent to info@inapta.org.

A panel will review your abstract and notification of acceptance will be given by Sept. 9, 2022. Abstracts will be reviewed in the order that they are received.

There is a 3,125-character limit for the text of your abstract submission which includes spaces, but not authors or institutions. Please indicate if you are submitting as a poster or platform presentation. The abstract should use between size 10-12 font with double spacing, and contain the following, based on type of project:
