

A CALL FOR POSTER AND PLATFORM PRESENTATIONS

2024 APTA INDIANA FALL CONFERENCE

Are you interested in sharing knowledge, skills, and evidence with your colleagues?

This is an excellent opportunity for PTs, PTAs, residents, and students to share practice outcomes through a poster or platform presentation at the 2024 APTA Indiana Fall Conference!

What is the difference between a poster presentation and a platform presentation?

Poster Presentations - 1:00 - 2:00 pm ET

Posters are visual presentations available for viewing during a designated period of time. During this hour, conference attendees are invited to visit the posters, meet the authors, and ask questions about the poster. Featured topics can include research, special interest case reports, case studies, or theory reports. Additional details will be provided to those accepted prior to the Fall Conference.

Platform Presentations - 3:45 - 4:45 pm ET

Not ready to present a full educational session, but looking for a little more than a poster? A platform session might be for you! Platform presentations are oral presentations of approximately 10-15 minutes, typically given by one individual. Platform presentations are best described as "mini" educational sessions and generally highlight "up and coming" research and special interest reports, such as implementation projects and quality improvement initiatives. Did you have a patient with a unique presentation or did you get an interesting outcome? Case reports can also be presented as a platform presentation. Time will be allotted at the end of each platform session for questions. Additional details will be provided to those accepted prior to the Fall Conference.

APTA Indiana Members who are registered for the Fall Conference will have no additional cost for platform or poster presentations. For non-members, or members not registered for the Fall Conference, there will be a \$25 charge for admittance into the Exhibit Hall and will also include lunch.

Abstracts must be submitted to info@inapta.org before 12:00 pm ET on July 31, 2024. A panel will review each abstract in the order received. Notification of acceptance or denial will be given by August 15, 2024.

There is a 3,125-character limit for the text of your abstract submission which includes spaces, but not authors or institutions. Please indicate if you are submitting as a poster presentation, a platform presentation or either. The abstract should be double-spaced, use size 10-12 font, and contain the following based on the type of submission:
